

coins, the object being to provide a simple, convenient and novel device of an ornamental nature for that purpose. The device consists 5 of a coin holder or receptacle in combination with an attachment, preferaby in the form of a miniature umbrella or parasol but of any other adaptable form, to indicate the contents of the said chamber. As the coins are 10 inserted into the chamber the resulting action of the piston as hereinafter described causes the umbrella to open. The first insertion results in a slight opening of the umbrella which then remains in its position until the 15 next coin is inserted. The second insertion causes the umbrella to open still further. As additional coins are inserted the umbrella opens gradually more and more until the coin chamber is filled to capacity at which point 20 the umbrella is fully opened. The umbrella indicates at all times the measure of the contents of the coin chamber.

In the accompanying drawings: Fig. 1 is an elevation of the entire device;

Fig. 2 is a cross sectional view; and Fig. 3 is a plan view of the device.

Reference numeral 1 indicates the holder or receptacle for the coins which consists of a hollow cylindrical member within which is 30 slidably arranged a piston 2 having the usual piston rod 3 which extends through a sleeve or stem 4 integral with or suitably connected to one end of the chamber 1 so as to form the main support or frame of the umbrella and a guide for the rod 3.

The lower end of the holder or receptacle 1 is provided with a cap or closure 5 which is removably attached to the end of the said holder. An aperture 6 is provided in the face 40 of said cap through which the coins are inserted into the chamber, said aperture having its lower edge 7 beveled so as to facilitate insertion of the coins into said holder. Secured to the interior of the cap 5 in the manner shown is a substantially U-shaped spring 8, the upper leg of which is positioned slightly

My invention relates to a savings device for to form a lip 9 on which the edge of the coin is adapted to slide when being inserted through the aperture. Arranged between the legs of said U-shaped spring and secured thereto at its ends is a coil spring 10 which 55 serves to hold the U-shaped spring in its normal position, that is, with its upper leg slightly above the lower edge and slightly below the upper edge of the aperture. As arranged, the upper leg of the U-shaped spring 60 forms a support for the piston when the coin holder or receptacle 1 is empty, the piston then being at its lowest point.

The sleeve or stem 4 is provided with slots 11 and 12 in its periphery for the reception 65 of a pin 13 which extends transversely through the piston rod 3, the ends of the said pin extending outwardly of the piston rod in position to ride in said slots. These slots extend throughout the greater length of the 70 sleeve or stem 4, and terminate, at their lower ends, a distance above the upper end of the coin holder or receptacle 1, and, at their upper ends, at a distance below the upper end of the stem or sleeve 4. The slots 75 serve to control, through the medium of the

pin 13, the upward and downward travel of the piston, for the purpose hereinafter described. Surrounding the sleeve or stem 4 is a col- 80 lar 14 which is slidably mounted on the said

sleeve or stem and which has at its lower end an outstanding flange 15 and at its upper end a similar flange 16 of greater diameter than the lower flange 15. The collar 14 rests at 85 all times on the projecting ends of the pin 13 so that any upward or downward move-ment of the piston 2 and piston rod 3 is imparted to the collar 14.

The indicating means referred to above can 90 be in any convenient adaptable form but as shown herein consists of a small umbrella or parasol having the usual covering 17 of any material, such as silk, cotton or the like, and the usual plurality of ribs 18 beneath such covering. Removably secured to the upper flange 16 are a plurality of connecting links above the lower edge of said aperture and flange 16 are a plurality of connecting links slightly below the upper edge of said aper- or rods 19, the upper ends of which are movture. The portion of said leg abutting the ably fixed to the umbrella ribs. The said 50 edge of said aperture is turned downwardly connecting links or rods serve to support the 100

umbrella covering, and to impart the necessary movement to the umbrella covering through the medium of the umbrella ribs to cause said covering to open or close upon the 5 upward or downward movement of the collar 14. The covering may be secured to the stem or sleeve 4 in the manner usual in umbrellas or may be detachably secured to the stem or sleeve as by providing the covering with a circular opening in its center which is adapted to be slipped over the upper end of the sleeve or stem 4. A metallic cap member 20 is removably attached to the upper end of the said sleeve or stem 4 to prevent 15 the covering from slipping upwardly and off of said sleeve or stem. To prevent slippage downwardly of the covering, the stem 4 may be provided with a transverse hole therethrough into which a pin 21 may be fitted so 20 that its ends project and form a support for said covering. In the preferred form of attaching the covering to the stem, the circular opening in the center of the covering is adapted to rest upon shoulders 22, formed 25 adjacent the upper end of the stem and to be tightly held in position on such shoulders by the end walls of the cap, when said cap is in position on the stem. In the operation of the invention each coin

30 as it is inserted through the aperture rides upwardly on the lip of the U-shaped spring until it engages the face of the piston which is caused to rise and to deflect the coin so that the same will lie flat on the upper leg of 35 the U-shaped spring while the piston will rest upon the coin. The piston having less resistance to movement than the U-shaped spring and the coil spring in combination, the insertion of each coin into the coin box 40 or receptacle causes an upward movement of the piston a distance equal to the thickness of the coin. The upward movement of the piston in turn imparts movement to the collar through the medium of the pin at the up-45 per end of the piston rod which in turn imparts movement to the umbrella or parasol and causes the same to be opened. Each coin inserted into the coin box or chamber causes a partial opening of the umbrella until the 50 coin chamber is entirely filled at which point

Thus the invention not only provides a novel form of receptacle for coins but also an indicating device therefor, whereby the number of coins contained in the receptacle or the total amount of the money contained therein can be easily determined at any time.

the umbrella is fully opened.

It is to be understood that the invention 60 is not to be considered as limited in the preferred form as described and as shown in the accompanying drawings, as any modifications thereof may be accomplished without departing from the scope of the appended 65 claims.

Having now particularly described the nature and object of my invention, I claim:

1. The combination with a savings bank of a receptacle comprising a hollow chamber, a piston within said chamber and means com- 70 prising an umbrella adapted to be operated by said piston to indicate the contents of said chamber.

2. The combination with a savings bank of a receptacle for coins, an aperture for the 75 insertion of coins into said receptacle, a piston within said receptacle, and means comprising an umbrella adapted to be operated by said piston to indicate the contents of said chamber.

The combination with a savings bank of a receptacle for coins, an aperture in said receptacle to permit insertion of coins therein, a support within said receptacle for such coins, a piston to be operated by such coins 85 and an indicating device comprising an umbrella actuated by said piston to indicate the measure of the contents of said chamber.

The combination, in a device of the character described, of a receptacle, an aperture 30 in said receptacle to permit the insertion of coins, a coil spring mounted between the legs of a U-shaped spring having one leg on a plane between the upper and lower edges of said aperture and substantially parallel 95 with and adjacent such aperture, and a lip at the end of said leg adjacent said aperture, so arranged as to assist in the insertion of coins into said receptacle.

The combination with a savings bank 100 of a receptacle for coins, a sleeve or stem connected at one end thereof, a piston rod within said sleeve or stem, a collar slidably mounted about said sleeve or stem, means connected to said collar to indicate the contents of 105 said receptacle, and means mounted in said piston rod to actuate said collar and said indicating means.

The combination with a savings bank of a receptacle for coins, a sleeve-like stem por- 110 tion connected at one end thereof and having a slot extending for substantially the length of said stem, a piston rod within said stem, a pin mounted transversely in said piston rod and so arranged that the ends of said 115 pin are slidably mounted in said slot, and a collar supported by the ends of said pin and arranged to slide longitudinally on said stem upon movement of said piston rod.

In a device of the character described 120 the combination with a savings bank of a hollow chamber having an aperture therein, a piston within said chamber, a coil spring mounted between the legs of a substantially U-shaped spring within said chamber, said 125 aperture and U-shaped spring being adapted for the insertion of coins into said chamber and said coil spring and U-shaped spring being adapted to support both said piston and such coins as may be within the chamber.

The combination with a savings bank of a receptacle for coins, a sleeve-like stem portion at one end thereof, a piston and piston rod within said receptacle and stem, an aperture in said receptacle, a coil spring and a substantially U-shaped spring mounted in combination within said receptacle and so arranged as to assist in the insertion of coins into said receptacle and to form a support for both said piston and such coins as may be within the chamber, a collar slidably mounted about said stem and arranged to slide longitudinally thereon, means connected to said collar comprising an umbrella to indicate the contents of said receptacle, and means mounted in said piston rod to actuate said collar and said indicating means.
